1. The office of phalelung rural municipal executive, Thoklimba Panchthar invites sealed quotations from registered Suppliers for the purchase supply and delivery of Non Swaged type Tabular POle.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of phalelung rural municipal executive, Thoklimba Panchthar.
3. A complete set of Bidding Documents may be purchased from the office of phalelung rural municipal executive, Thoklimba Panchthar by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, Vat/Pan Registration certificate, Tax clearance certificate till Fiscal year 075/076 and upon payment of a non-refundable fee of NRs. 1000.00 till 2076 ashwin 12 during office hours.
4. Sealed bids must be submitted to the office of phalelung rural municipal executive, Thoklimba Panchthar by hand before 12: 00 Noon on 2076 Ashwin 13. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2: 00 P.M on 2076 Ashwin 13 at the office of phalelung rural municipal executive, Thoklimba Panchthar. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs.45000, which shall be valid for 30 days beyond the validity period of the bid i.e. 2076 Mangsir 13. If bidder wishes to submit the Cash Security, the cash should be deposited in Dharauti Account No. 07300091CA maintained at Prime Commercial Bank Phalelung Branch and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. The Purchaser reserves the right to accept or reject, wholly or partly any or all the Sealed Quotations without assigning any reason, whatsoever.
